1. ACTION REQUESTED/PURPOSE:

Award and authorize staff to enter into a Construction Manager Agreement for RFQ-09-02 CONSTRUCTION MANAGEMENT FOR THE PROPOSED NEW BOSTON RED SOX SPRING TRAINING FACILITY, to Kraft Construction Company, Inc. for the sum of 4% construction fees and .5% for preconstruction fees based upon the GMP Construction costs. Also, request that the Board approve waiving of any formal process (if needed) and authorize the use of Direct Material Purchase Orders based on CM's competitive process, which allows the County to purchase directly from suppliers of equipment and/or materials as a cost/time saving measure. Authorize Chairman to execute the Agreement on behalf of the Board upon receipt.

10. Background:

On February 10, 2009 the Board concurred with and authorized contract negotiations to commence with Kraft Construction Co., Inc. under RFQ-09-02 CONSTRUCTION MANAGEMENT FOR THE PROPOSED NEW BOSTON RED SOX SPRING TRAINING FACILITY.

Contract negotiations were successful in the development of the construction and preconstruction CM fees. A letter was received from Kraft Construction on April 1, 2009 proposing a 4.5% construction management fee. Four (4%) percent construction fees and a half (.5%) percent for preconstruction fees. A Guaranteed Maximum Price (GMP) will be brought back for Board approval.

Kraft Construction Company, Inc. will be required to enter into the Construction Manager Agreement and provide the necessary Public Payment and Performance Bond and certificate of insurance.


Subject: New Boston Red Sox Spring Training Facility
